The KEMPTON COUNTRY FAIR, hereinafter referred to as the **KCF**, does hereby agree to let:

Hereinafter referred to as **EXHIBITOR**, frontage in the display area at the five-day KEMPTON COUNTRY FAIR on June 12 - 16, 2012: The **KCF** agrees to reserve space until Fair time provided that:

EXHIBITOR signs and returns this contract, along with full payment, **by June 1, 2012.**

First come first serve basis.

EXHIBITOR agrees to have full display erected by **4:00 P.M. on Tuesday June 12, 2012** and removed by **12:00noon on Sunday June 16, 2012.**

EXHIBITOR agrees to indemnify and hold harmless **KCF** from and against all liability damages occurring in the course of **EXHIBITOR'S** operations under this agreement.

EXHIBITOR must provide to **KCF** a certificate of Insurance to cover **EXHIBITOR'S** operations during the five-day KEMPTON COUNTRY FAIR. The Insurance will include **Kempton Country Fair and Kempton Community Recreation Center** as covered. A PA Sales Tax number must also be provided.

EXHIBITOR agrees to keep full display erected till 10:00 P.M. Saturday, June 16, 2012 **KCF** will revoke it's obligation to reserve display space if **EXHIBITOR** fails to return this agreement with proper information needed and make payment by June 1, 2012. or if **EXHIBITOR** fails to erect display by 4:00 P.M. on Tuesday, June 12, 2012. If **KCF** is prevented from holding the Fair or any element thereof by reason of cause which are beyond it's control, such as acts of god, forced majority strike, epidemic, accident, transportation delays, sickness, or government action or any other causes of like nature. Sponsor shall not be in breach hereof and shall have no obligation to the **EXHIBITOR**, except to refund **EXHIBITOR'S** display fee. No EXHIBITS may be removed before 10:00 p.m. Saturday, June 16, 2012. Main buildings will be locked at 11:00 p.m. Exhibits may be removed after 9:00 a.m. Sunday morning. Anyone removing exhibits before 10:00 p.m. can be excluded from future events.
